Competition Secretary Report - GJ

During 2024 we ran 3 events, 2 simulations and 1 annual competition, all appeared to be well received and lessons learned added to our checklists.

I'm conscious that a decision will need to be made about events in 2025, I'm adding this as a note to the report to prompt the new competition secretaries, as ice time needs to be booked imminently to finalise this year's programme.

Succession – As I'm stepping down I to recognise that I have been fortunate to have the support this year from KB, MK and JK, this has allowed me to share the knowledge I've gained over the past 2 years.

My intention is to take a background role for the next 12 months while supporting the new competition secretaries as required, whilst they lead the planning and delivery of upcoming events.
